The school has a Published Admission Number (PAN) of 30.

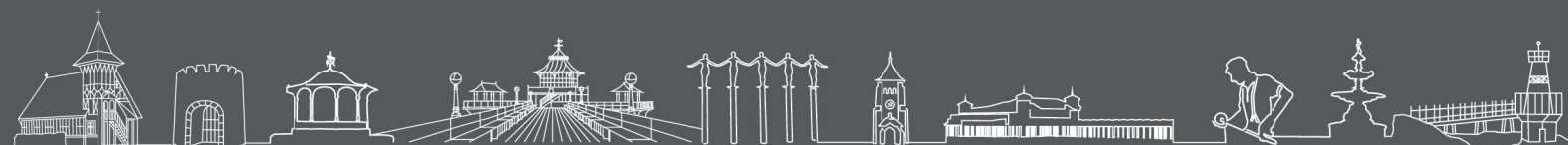
55 preferences have been received for the school. It has, therefore been necessary to use the oversubscription criteria, as outlined below, to determine which of the applicants should be offered the places available.

The distance between home and school for the last child offered a place was 0.329 miles, as measured in a direct line.
