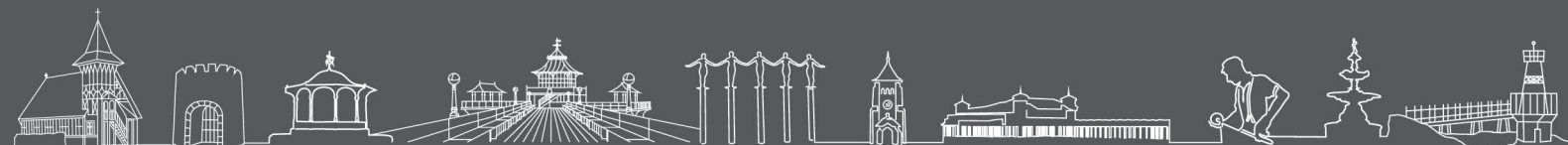

The distance between home and school for the last child allocated to the West Wick site was 0.498 miles.

**Update 24 May**

9 spaces available due to parents not accepting the offer of a place. 5 applicants were considered for the vacancies and 3 allocations were made, all of which were assigned the Hewish site. The west Wick site remains at capacity.
