North Somerset Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 82, 83 and 84 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") and of all other enabling powers, after consultation with the Chief Officer of Police, in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:-

- This Order shall come into operation on the XX XXXX 2024 and may be cited as the North Somerset Council (B3133, North End Road & High Street, Yatton, North Somerset) 20 mph & 30 mph Speed Limit Order 2024.
- 2. No person shall drive a motor vehicle at a speed exceeding 20 miles per hour on the lengths of road specified in Schedule 1 to this Order.
- 3. No person shall drive a motor vehicle at a speed exceeding 30 miles per hour on the lengths of road specified in Schedule 2 to this Order.
- 4. The section listed in Schedule 3 to this Order is hereby revoked.
- 5. No speed limit imposed by this order applies to vehicles falling within regulation 3 (4) of the Road Traffic Exemptions (Special Forces) (Variation and Amendment) Regulations when used in accordance with regulation 3 (5) of those regulations.
