Public Path Diversion Order No. 5 2024

On 30 July 2024 North Somerset Council ('NSC') confirmed the above Order, made under section 119, Highways Act 1980. The effect of the Order as confirmed is to divert that part of Public Footpath LA 22/34 in the Parish of Clevedon within the District of North Somerset as described below:

From point That part of footpath LA 22/34, from point A (grid reference ST 42456 72259) at Norton's Wood Lane, running in a northerly direction for approximately 76 metres to point B (grid reference ST 42448 72328), then in an easterly direction for approximately 73 meters to point C (grid reference ST42517 72345) then in an easterly direction for approximately 45 metres to point D (grid reference ST 4255 972352) as shown by a bold continuous line on the attached Map No. PPO 189.

to A footpath running from a pedestrian gate at point E (grid reference ST 42584 72235) running in a northerly direction for a distance of approximately 121 metres to point D (grid reference ST 42559 72352) as shown by a bold broken line on the attached Map No. PPO 189. The proposed path will have a natural surface and a width of 2 metres.

The Order comes into force on 25 September 2024 but, if any person aggrieved by the Order desires to question its validity, or that of any provision contained in it, on the ground that it is not within the powers of the Highways Act 1980, as amended, or on the ground that any requirement of the Act, as amended, or of any regulation made under the Act has not been complied with in relation to the Order, he or she may under paragraph 2 of Schedule 2 to the Act as applied by paragraph 5 of Schedule 6 to the Act, within six weeks from 25 September 2024, make an application to the High Court.


