Commercial Event	Any event which charges an admission price to enter the event site or which charges on the site for any service or goods available.
Market-Based Event	Any event where the sale of food or goods is the primary attractor for those attending.
Charity Event	An event organised by a registered charity where all proceeds are retained by the named charity to continue its work.
Fund Raising Event	An event where all residual income after the costs of producing the event are deducted are paid across to the declared beneficiaries.
Community Event by a CIC	An event produced by a CIC to benefit the community for social or environmental purposes to provide education, health care, and environmental benefits.
Non-Motorised or Sustainable Sporting Event	An event which does not have motorised transport as its primary focus either offers the opportunity to participate or be a spectator, including but not limited to rugby, walks, running events, cycling, volleyball, polo, EV Racing and any associated fan zones.
Motorised Sporting Event	An event which either offers the opportunity to participate or be a spectator in motorised sports, including but not limited to motorcross, air races/shows, car shows (static or mobile) and any associated fan zones
Concert Performance	Any event where music is the primary attractor for those attending.
Civic or Ceremonial Event	As determined by NSC, an event which is organised by a Town Council or other recognised public body including but not limited to Remembrance Events / Armed Forces Day / Beacon Lighting.
Road Closure events with no Infrastructure	An event which takes place within a road closure that requires no infrastructure, such as marches/walks /parades and is dealt with directly through Highways
Road or Public Right of Way events with low impact	An event which takes place on the road or on public right of way which has little to no impact on every day usage such as a sponsored walk.
