

NORTH SOMERSET COUNCIL
CONSTRUCTION OF SPEED CUSHIONS AND SPEED TABLES,
NORTH END ROAD, HIGH STREET, MENDIP ROAD, STOWEY ROAD - YATTON

Notice is hereby given that North Somerset Council in exercise of the powers conferred by section 90A of the Highways Act 1980 (hereinafter called 'the Act') and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with section 90C (1) of the Act and those bodies or persons prescribed by the Highways (Road Humps) Regulations 1999 (hereinafter called 'the Regulations') and in accordance with section 90C (2) of the Act intends to construct raised speed tables and speed cushions at the locations specified in the Schedule to this notice.

1. **Flat Top Speed Cushions** referred to in Schedule 1, will be in pairs, each cushion being 2 metres in length, 1.75 metres wide and 75 millimetres in height, subject to tolerances in the Regulations.
2. **Full width Flat Top Speed Tables** referred to in Schedule 2, being respectively 7.0 & 7.8 metres in length and 75 millimetres in height, subject to tolerances in the Regulations. These will extend over the full width of the carriageway.
