To close temporarily to foot passengers the lengths of footpaths specified in Schedule 2. To restrict temporarily the No Waiting or Loading Restrictions specified in Schedule 3. Exemptions are included for emergency services, for Public Buses at Bus stops, for enforcement of the restrictions and for any vehicle with agreed dispensation from North Somerset Council undertaking emergency work.
