Summer Lane, Banwell, North Somerset
(TEMPORARY PROHIBITION OF USE BY VEHICLES) ORDER 2024

WHEREAS North Somerset Council (hereinafter referred to as "the Council") being the highway authority for Summer Lane, Banwell in the District of North Somerset is satisfied that vehicles in a length of the said road should be restricted because of the likelihood of danger to the public consequent upon increased traffic levels on Summer Lane during work by North Somerset Council that requires a prohibition of use by vehicles on Wolverhill Road.

NOW, THEREFORE, the Council in exercise of its powers under section 14(1) of the Road Traffic Regulation Act 1984 as amended (hereinafter referred to as "the Act of 1984") and of all other enabling powers hereby makes the following order:-

1. Save as provided in Article 2 of this order no person shall cause or permit any vehicle from proceeding in Summer Lane (between the junction with Knightcott Road and the junction with Wolverhill Road).
2. Nothing in Article 1 of this order shall apply to emergency services, works access necessarily proceeding to or from the said works, and as works permit for premises which may only be accessed via the closed section of road.

This order shall come into operation on the 16th September 2024, anticipated to be of 30 weeks in duration, for a maximum period of eighteen months and may be cited as the North Somerset Council, Summer Lane, Banwell, North Somerset (Temporary Prohibition Of Use By Vehicles) Order 2024.
