The above-named Agreement made on 30 November 2024 under section 25 of the Highways Act 1980, had the effect of creating a public bridleway by agreement with the landowner. The bridleway commences at Grid Ref ST 41562 67013 and proceeds in a north westerly direction for approximately 19m to Grid Ref ST 41546 67022, then north north westerly direction for approximately 15m to Grid Ref ST 41539 67038, then westerly for approximately 37m to Grid Ref ST 41504 67028. This bridleway is to be known as Bridleway LA21/47 and is depicted upon the plan attached to the agreement with available width of 5-6 m. This dedicated section provides connectivity to the recently created connection from Arnolds Way (which upon transfer to North Somerset will be dedicated as a bridleway) and Duck Lane. Under section 25, there is no right of objection, and the Agreement has taken immediate effect.
