Changes to the criteria for MAISEY referrals so that those who can be referred are known to more than one professional, not including Area SENCo or Health Visitor as universal services MAISEY. As a result, referrals are no longer mandatory for all Top Up Funding applications.

Top Up Funding packs should be scanned and emailed to ey.send@n-somerset.gov.uk whenever possible. It is no longer necessary to use Egress but providers must use their own methods for emailing sensitive data.

Wherever possible, scan pages together. If this is not possible, ensure that at least the TUF application form document is named so we are able to find this key document.

The EY TUF application form should be completed electronically or typed, not handwritten.

Packs should only include the most up to date professionals report. Multiple reports from the same service are not needed.

There is no need to include ASQ's if a child has already started an Autism Assessment.

If including an Autism Assessment just send in the summary/overview unless there is something specific, you feel you haven't evidenced elsewhere. If this is the case, highlight just that information.

Avoid sending information irrelevant to the criteria requested e.g., hospital discharge information for a B2 application.

Providers are asked to separately send MAISEY referrals to ey.send@n-somerset.gov.uk if appropriate, do not include them in the Top Up Funding applications.
