This Order is made by North Somerset District Council ("The Council") under Section 53(2) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to that authority that the County of Somerset Definitive Map and Statement Axbridge Rural District requires modification in consequence of an event specified in section 53(3)(c)(i) namely that a right of way which is not shown on the map and statement subsist or is reasonably alleged to subsist over land in the area to which the map relates, being a right of way such that the land over which the right subsists is a public path, a restricted byway or, subject to section 54A, a byway open to all traffic.

The Council have consulted with every local authority whose area includes the land to which the Order relates. The Council hereby orders that:

- 1. For the purpose of this Order the relevant date is 1st October 2025.
- The County of Somerset Definitive Map and Statement Axbridge Rural District shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to this Order.
- 3. This Order shall take effect on the date it is confirmed and may be cited as the North Somerset District Council (Upgrade of part of Footpath AX3/42 to Bridleway AX3/62 and continuation of additional Bridleway AX3/62 Havage Drove) Puxton Definitive Map and Statement Modification Order No 1 2025





If the Order is submitted to the Secretary of State for the Environment, in whole or in part, any representations or objections which have been duly made and not withdrawn will be sent with it.

# EXPLANATORY STATEMENT THIS STATEMENT DOES NOT FORM PART OF THE ORDER

Public footpaths, bridleways and byways open to all traffic are recorded on Definitive Maps and Statements. These maps and statements provide conclusive legal evidence of the existence of public rights. North Somerset District Council is responsible for the Definitive Map and Statement and has a duty to amend them when evidence suggests that they are inaccurate or incomplete. Such amendments are made by means of modification orders made under Section 53 of the Wildlife and Countryside Act 1981. These orders do not come into effect until confirmed; if there are any objections the Council must refer the order and objections to the Secretary of State for the Environment, Food and Rural Affairs, who will decide whether or not to confirm the order.

## Definition of a Footpath

A highway over which the public have a right of way on foot, cycling and horse riding.

This route to be known as Bridleway AX3/62 is the subject of investigation following the submission of an application dated 4 April 2022. That application claims that a route, which runs between Box Bush Lane and Puxton Lane in the parish of Puxton should be recorded as a Bridleway.

North Somerset Council's Rights of Way Sub Committee considered this application on the 18<sup>th</sup> November 2024 and formally

#### Resolved:

- (i) that the Public Rights of Way Sub Committee authorised the relevant Officer to make a Definitive Map Modification Order for the route A-B-C on the grounds that there is sufficient evidence that Bridleway rights should be recorded on the Definitive Map.
- (ii) that the Committee authorised the confirmation of the Order if no representations or objections were received.
- (iii) that if objections were made, the Order would be forwarded to the Secretary of State for determination and subject to the Officer being content that there would be no significant change to the balance of evidence, the council would support the Order at any subsequent Public Inquiry.

The width of this Bridleway is as defined upon 1903 OS Map which details the alignment of the track and the rhyne network laid out adjacent to the track The width of the track varies between 4.5m and 3m. Between Points "A" and "B" the width is 4.5m to 4m, between Points "B" and "C the width is 4m and between Points "C" and "D" the width is 4m to 3m.

To be relevant, objections or representations should relate to the question as to whether this is a historically used route; other objections or representations (e.g. relating to privacy, security, suitability, desirability or amenity) may be held to be irrelevant.

The right of objection to an order is a statutory right, but it should be exercised in a reasonable manner. It should be noted that all comments received will form part of the case for this Order and will be forwarded to the Planning Inspectorate and interested parties.

If there are no objections to the order, or if any made are duly withdrawn, the authority may confirm the order, and the Definitive Map and Statement will then be modified. If there are any objections which are not withdrawn, then North Somerset District Council must refer the order and objections to the Planning Inspectorate acting for the Secretary of State for the Environment, Food and Rural Affairs. The Department will appoint an independent Inspector to consider the order and hear the objections, normally by holding a local Public Inquiry. The Inspector may confirm the order, with or without modifications, or may decide that the order should not be confirmed.
