This order was required because of the likelihood of danger to the public consequent upon work by North Somerset Council for Wall repairs. This order will become operative on the 10 November 2025 for a maximum period of eighteen months. However, the closures may not be implemented for the whole of the period but only as necessitated by the works which is anticipated to be of 5 days in duration. Appropriate traffic signs will be displayed when the measures are in force.
