The Home to School Transport Service recently introduced a new Post-16 policy, but excluded charging for Post-16 SEND transport as part of the new policy following engagement with key stakeholders at the end of 2024 and the start of 2025.

# What is changing in relation to this project?

This EIA is being completed to assess the impact of introducing those charges for Post-16 SEND students/families. The Post-16 SEND charge would align to the Vacant Seat Payment Scheme charge (currently £817 per year) already in place on eligible routes for Mainstream students (both of compulsory school age and Post-16).

Changes will be communicated through early engagement with key stakeholders, including the North Somerset Parent/Carer Forum and Post-16 Educational Providers. Additionally, direct communication will be had with those existing service users through letter reminders (which are sent anyway, but to include a section on charging), along with "prompt" letters for potential upcoming Post-16 Service Users that they must apply for transport (which is completed anyway, but to include a section on charging).

Furthermore, it will/can be advertised on the Local Authority social media pages, and specific reference to the new charges will be added before the application and details requested during the application (i.e. not hiding it).

When the Post-16 Policy changed for September 2025, there was a noticeable increase in the volume of work for the Home to School Transport team – this ranged from higher volume of emails relating to travel offers not being as expected, queries on why the contracted service isn't available this year compared to previous, through to an significant uplift in appeals and additional work building individual Personal Travel Allowances (and the knock-on impact on finance colleagues through additional PO's and payments required throughout the year).
