# Description of the project:

North Somerset Council has a number of public health responsibilities given to us by the Department of Health and Social Care and the Public Health Grant is allocated to each local authority to achieve those outcomes. That resource is invested in a range of programmes and methods of achieving benefit including staffing, direct service provision, commissioning of external providers and investment in partnership working. Within the public health grant we invest in several other Council teams and services that deliver public health outcomes, primarily children's and adults focused services and support.

We expect to receive a three-year public health grant settlement in late 2025 or early 2026 which will help to confirm our budget plans over a longer period and provide more stability for commissioning plans and directly provided services and support.

This ambition relates to maximising efficiency in delivery of funded services, particularly where we can integrate support to provide better outcomes and more effective delivery.

At this stage, we do not have a detailed plan for how budgets can be released into other service delivery within the Council for 2026/27 but this will focus on a combination of a review of commissioning responsibilities, efficiencies in programme delivery and main or special grant increases in income. The target for next year represents less than 1% of the total grant so is a reasonable assumption of efficiency gains that should be possible.

#### **Summary of changes:**

The detail of the proposal is not yet clear, because we are dependent on the overall funding envelope but however those proposals emerge, any resources will be reinvested in public health outcome delivery, with a focus on prevention and tackling inequalities. The aim will be to protect and where possible enhance frontline delivery.
