Overview of the work of SACRE

Since 1988, each Local Authority (LA) has been required by law to have a Standing Advisory Council for Religious Education (SACRE).

The remit of a SACRE is principally to oversee the Religious Education (RE) and collective worship within the authority principally to:

- advise North Somerset Council upon matters connected with Religious Education and Collective Worship in community schools and in foundation schools which do not have a religious character. Religious Education in these schools is to be given in accordance with the Agreed Syllabus;
- advise North Somerset Council on teaching methods, choice of materials and teacher training in Religious Education and Collective Worship;
- require North Somerset Council to review the locally agreed syllabus for religious education at least every five years.

The reporting period of the 2024 - 2025 report starts from September 1st 2024 and runs to August 31st 2025.

SACRE met on three occasions during the academic year 2024 – 2025, all of these were virtual meetings.

Section 2: Religious Education

The Locally Agreed Syllabus and RE in schools

RE is not part of the national curriculum. Each LA is required to produce an Agreed Syllabus for RE. Each LA is required to begin reviewing the current Agreed Syllabus within five years of its production.

Standards and monitoring of RE

During the year covered by this report the SACRE has undertaken its role for monitoring religious education in North Somerset in a number of ways. The information presented to the SACRE has included the DfE Workforce Data, examination results and Ofsted reports. These items are noted in the minutes of the relevant meetings and are also included in this report.

Sarah McGahern, Lead Early Years Consultant holds responsibility for SACRE support and liaises with the RE consultant.
