Road Traffic Regulation Act 1984

North Somerset Council, (Speed limit Restrictions, North Somerset)

Consolidation Order 2024 (Variation No.10) Order 2026

Ref: SLTR/DB/2602

Notice is hereby given that North Somerset Council propose to make an order in exercise of its powers under the Road Traffic Regulation Act 1984 as amended. The general effect of the order shall be to amend the North Somerset Council (Speed Limit Restrictions, North Somerset Consolidation Order 2024 to install a 40mph speed limit, remove the restricted road status and implement a 20mph speed limit for the certain roads in the village of Winscombe. The extent of the proposals are described in the Schedule to this Notice.

Only those roads affected by the Banwell Bypass works are included within this proposed Order.

Full details of the proposals are contained in the draft Order which, together with the plan, Statement of the Council's Reasons for proposing to make the Order may be inspected at the following locations: -
